The Governing Council of SOSVA Training and Promotion Institute (STAPI) takes great pleasure in presenting its Twenty Third Annual Report together with the audited statements of accounts for the financial year 2022-2023.

STAPI as a support service organization, continued to offer a wide variety of services to the NGOs in Maharashtra, maintaining a close association with all its partnering organizations and partner NGOs during the period under report.

For the Twenty Third year in succession, STAPI continued its systematic efforts for increase in its outreach and upgrading the scope and quality of services it offers to the NGOs.

The year witnessed initiation of Aftercare Services Project for Young Adult Orphans from Palghar district of Maharashtra with the support of TAKE Solutions Limited Chennai and successful completion of America Rescue Plan Act (ARPA) project for COVID 19 vaccination of PLHIV's and networks and NGOs /CBO's working with key population in non-cluster districts of Satara Sangali Kolhapur and Solapur.

Meetings of Governing Council and General Body of the Society :-

The Governing Council met on 62nd, 63rd, 64th, 65th, 66th Governing Council Meetings held on 25/5/2022; 16/7/2022; 20/8/2022; 26/9/2022; 1/12/2022 respectively.

The 22nd Annual General Meeting of STAPI was held on 26/9/2022.

I) Training Activities:-An Overview:-

A total of 10 trainings were organized during the year 2022-2023.

The details of training activities are at Annexure-1.

II) About Projects:-

1) Community Action For Health (CAH) Project with the support of National Health Mission (NHM), Mumbai and Technical support by State Health Services Resource Centre (SHSRC) :-

The focus and emphasis of CAH project is communitization of key village institutions and strengthening of Village Health Sanitation and Nutrition Committees and Village Health Volunteers and activation of Village Health Gramsabha's aiming at community ownership with more accountability and responsive behavior by the local population in assuring accessible and affordable public health services to ensure no one left unattended.

The project activities included district and block based project activities by the district partner NGOs; consultations and review meetings with officials of NHM, AGCA, SHSRC district and block level administration, State Planning and Monitoring and Mentoring Committees, district partner NGOs.

More details on the CAH Project activities are at Annexure -2, 2A, 2B and 2C.

2) Meeting Targets and Maintaining Epidemic Control (EpiC) Project:-

Under the USAID-funded Meeting Targets and Maintaining Epidemic Control (EpiC) project, FHI 360 selected STAPI as a Lead Partner in implementing EpiC project on technical assistance (TA) for organizational development (OD) of 14 civil society organizations, community based organisations, and PLHIV networks from two PEPFAR priority districts of Thane and Pune since June 2021. (9 from Thane and 5 from Pune). The project focus is on capacity development of CSOs, CBOs & NGOs working for the key HIV populations (FSW, MSM, PLHIV, PWID).

EpiC in India aims to strengthen organizational capacities of local community-based organizations (CBOs), key population (KP)-led organizations, and people living with HIV (PLHIV) networks to effectively manage and implement HIV programs; and to support resource mobilization to enable them to contribute to HIV response in their districts and states on a sustained basis.

Project activities included introductory meetings of partner NGOs, conduct organizational assessment using the E-CAP tool, preparation of capacity development plans (CDP) of partner NGOs, mentoring visits and capacity building of partner NGOs in specific areas of governance, financial management, project writing and proposal development, resource mobilisation, use of social media, monitoring and evaluation to name a few.

The Co Learning Meeting with LEPR Telanga as a part of Epic project was also organized at Pune during 30 January 2023- 1 February 2023 .

Details of Thematic Trainings under EpiC project are at Annexure- 3.

3) America Rescue Plan Act (ARPA) Project:-

STAPI as a Implementing Partner was entrusted the responsibility of addressing vaccine hesitancy and promoting access to COVID-19 vaccines and supporting safe and uninterrupted access to HIV services and commodities for key populations (KPs) and people living with HIV (PLHIV) through collaboration with four PLHIV networks and NGOs /CBO's working with key population in non-cluster districts of Satara, Sangli, Kolhapur and Solapur.

The project activities included :-

i) COVID 19 preventive vaccination of 5469 key population (KP's) and People living with HIV/AIDS (PLHIV's) (3536 through community champions and 1903 through helpdesks)-First Dose- 503; Second Dose - 2051 and Precautionary Dose – 2885 as per the inclusion criteria approved by USAID

ii) Conduct of Seven COVID 19 Vaccination Camps for KP's and PLHIV's for first second and precautionary dosage as per the inclusion criteria approved by USAID at Rural Hospital Ichalkaranji District Kolhapur; ART Centre Gadhinglanj District Kolhapur; Government Medical College, District Kolhapur; Savitribai Phule ART Centre District Kolhapur and Kavathe Mahakal ART Centre Block Miraj District Sangli.

iii) Setting up the Help Desks at District Civil Hospitals of Satara, Sangli and Solapur districts of Maharashtra during July 2022 - September 2022.

iv) Development of Risk Communication and Community Engagement (RCCE) materials for addressing vaccine hesitancy and prompting access to vaccination based on the inputs feedback and responses of KP's and PLHIV's. Details of Community Champions Project ARPA is at Annexure4

4) Implementation Support Agency – Jal Jivan Mission Block Shirur District Pune :-

The second phase of Implementation Support Agency for Har Ghar Nalse Jal under Jal Jivan Mission was implemented during the period August 2022 - July 2023.

The various project activities included:-

- Sensitization of local population about different aspects of the Jal Jeevan Mission
- Capacity Building Trainings of 768 Members of Village Health Sanitation and Nutrition Committees of 52 villages of Shirur Block of Pune District
- Conduct of GramSabha's in 48 villages of Shirurblock
- Facilitation for constitution of village health, sanitation and nutrition and water committee (VHSNC) in 75 villages of block Shirur
- Conduct of need assessment and motivation for functional household tap connections in 40 villages of Shirur block
- Awareness sessions with 800 SHG women and Gram Panchayat Members from 23 villages on various aspects of water such as rain water harvesting, water quality, water-borne disease, water saving, water handling, drinking water source sustainability
- Training of 100 women from 20 villages on water testing using field test kit
- Capacity building of 120 local youth from 54 villages from Shirur block as plumber electrician, pump operator for cost effective operation and maintenance
- Co-ordination between District Water Sanitation Mission (DWSM) and village health sanitation nutrition and water committees (VHSNC)
- Assistance in community led water campaigns initiated by Government of India/ Maharashtra State Government to name a few

5) Project Phoenix :-

The project Phoenix aimed at assessing and understanding the needs of COVID 19 affected families from Shahapur and Murbad blocks of Thane district. The project objectives were :-

- i. To provide the financial support to COVID 19 affected families in the areas of education, vocational skills training, health and livelihood/ income generation activities (who have lost bread earner and child who has lost parents/single parent /dear and near one's) during the pandemic.
- ii. To advocate with the Government and Govt. apex organizations for linkages with COVID - 19 specific campaigns/schemes and availment of other Government Schemes to COVID 19 affected households from Shahapur and Murbad blocks of Thane district of Maharashtra

The project activities included data collection through home visits, follow up home visits, co-ordination with block and district level administration and support to deserving women from the COVID 19 affected families in 3 areas of education, vocational skills training, health and livelihood/income generation activities.

The project was supported by Shri. Avinash Kenkare, an individual donor, through Maharashtra Foundation, New York in January 2022.

The project activities were later extended to Shirur block of Pune district, Pune, Pimpri, Thane and Miraj Sangali Kupwad Municipal Corporation areas.

Total of 125 families were surveyed (77- from Shirur block of Pune district; 17 from Pune Municipal Corporation; 27- from Pimpri Chinchwad Municipal Corporation; 2 - from Thane Municipal Corporation and 2 from Miraj Sangali Kupwad Municipal Corporation respectively during the period under report.

Out of the total 125 families surveyed, the financial support was extended to 103 beneficiaries from 67 households respectively during the period under report.

- i) 43 beneficiaries from 30 households from Shirur block of Pune district
- ii) 21 beneficiaries from 14 households from Pune Municipal Corporation
- iii) 34 beneficiaries from-19 households from Pimpri Chinchwad Municipal Corporation
- iv) 2 beneficiaries from 2- households from Thane Municipal Corporation
- v) 3 beneficiaries from 2 households from Sangali Kupwad Municipal Corporations

6) Integrated Village Development Project Suksale village of Vikramgad Block Palghar- CSR Partnership with the support of UPS Express Private Limited Mumbai :-

UPS Express Private Limited Mumbai supported integrated village development project aimed at comprehensive and holistic development through interventions in the areas of health, women empowerment and livelihood /income generation activities in Suksale village of Vikramgad Block Palghar district during the period January 2022 –March 2023.

The highlights of the project activities included:-

- i. Entrepreneurship Development Trainings of 209 SHG Members of 25 SHG's in six batches organized during June 2022 - March 2023
- ii. Vocational Skills Trainings of 110 SHG Members in the areas of Tailoring, Quilt Making and Incense Sticks Making organized during January and February 2023
- iii. Health Check up and medical consultation of 542 beneficiaries in 4 health camps(62 male,197 female and 283 children) organized on 12/5/2022; 22/6/2022; 20/1/2023 and 28/1/2023

7) Project Maharashtra Alliance Young Adults (MAYA) - CSR Partnership with the support of TAKE Solutions Limited

TAKE Solutions Limited Chennai approved a project for aftercare services for young adult orphans (Age Group 18-23) from Palghar district of Maharashtra.

The project activities included viz. approval from the respective State and district authorities, Visits to Child Care Institutions, data collection and analysis of young adult orphans, identification of deserving YAO's, home visits.

STAPI is grateful to all its donors and partners for their valuable support during the period under report

Linkages & Networking with Other Organizations:-

STAPI has strong linkages and networking with several partners viz. NGO Networks across Maharashtra, Central and State Government Agencies- State Family Welfare Bureau, State Health Systems Resources Centre, Zilla Parishad's, District Health Officers, Panchayat Samiti's, Experts from State Health Services, State AIDS Control Societies, and management institutions.

The geographical network has greatly enhanced STAPI's outreach and as a result of which many NGOs have been able to access STAPI Services. STAPI also has a good network with the donors, well-wishers, members of Advisory Committee, Members of Screening Committee and Volunteers.

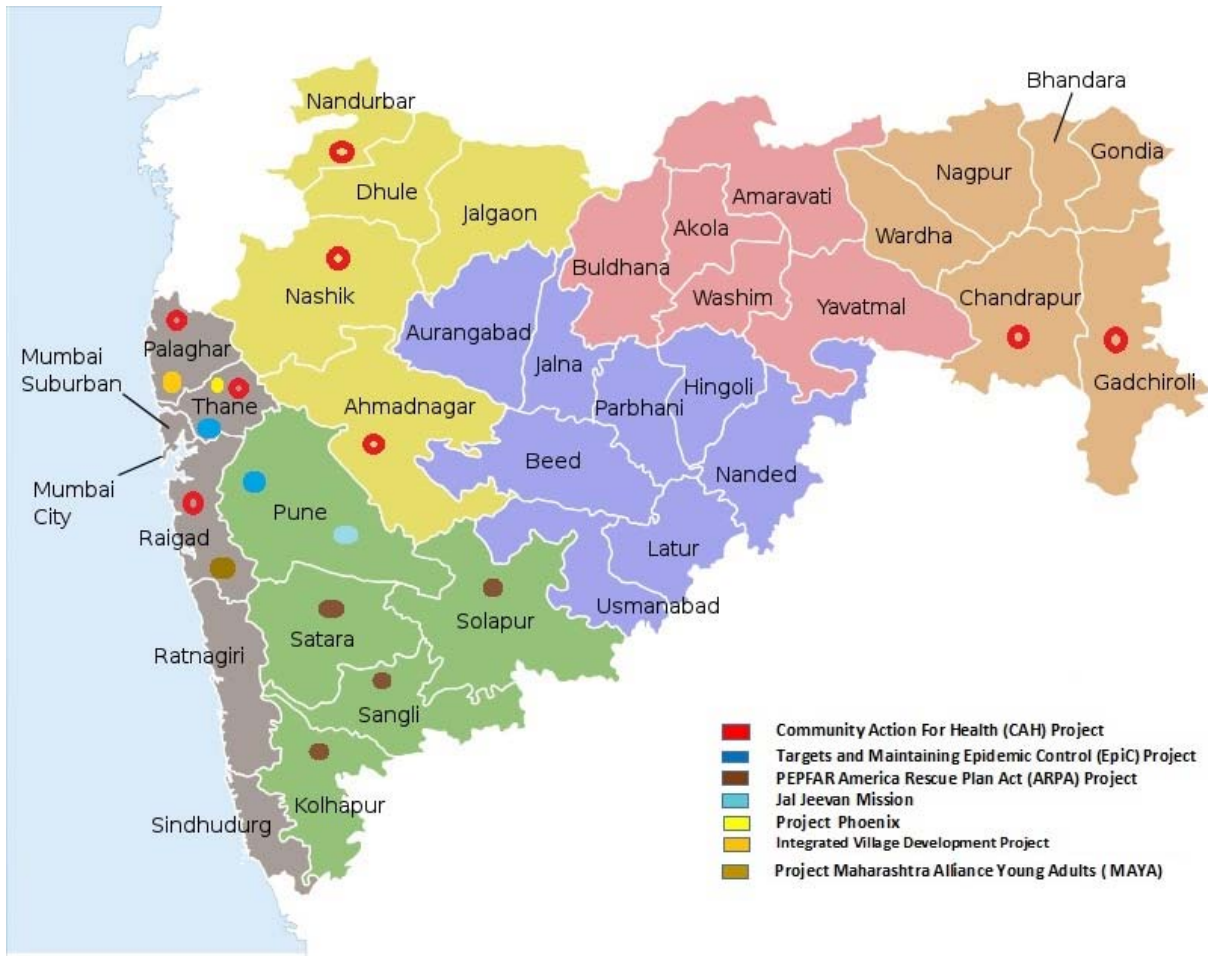

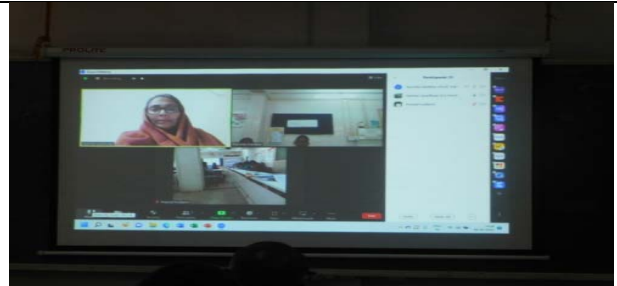

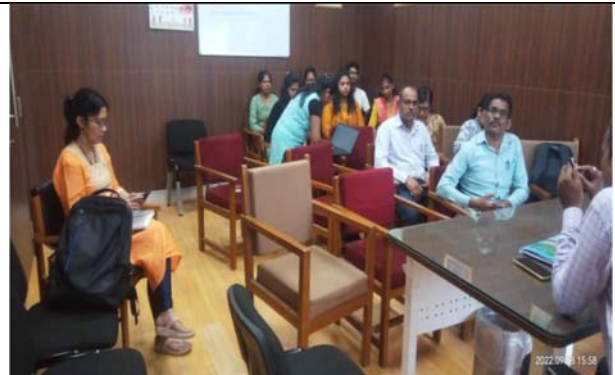
